

Test on Rambam Hilchos Nizkei Mammon Chapter 2,10 - 3,11:

1. Mr. Mazik's bird flies through a רשות הרבים and through the force of its wings, breaks \$50 worth of bottles. What is the law? Why?
2. Mr. Mazik's rooster enters a רשות הניזק and pecks away at a brand new rope, while eating the food on top of it. He eats the food and breaks the rope. What is the law? Why?
3. What is the law in the above case, if it occurred in a רשות הרבים? Why?
4. Mr. Mazik's goat jumps up to the roof of Mr. Nizak's house. The goat slips and falls on Mr. Nizak's vegetables and damages them. What is the law? Why?
5. Mr. Kelev's dog enters Mr. Aish's courtyard by digging a hole underneath the strong, closed, protective fence. He grabs a cookie, which has a flaming hot coal attached to it. He takes the cookie and coal and goes into Mr. Aish's grain heap. He eats the cookie, and drops the coal on the grain heap and burns it all up. What is the law? Why?
6. Mr. Rasha excites Mr. Kelev's dog to bite and injure Mr. Shelomazel. Mr. Kelev watches the event and says nothing. What is the law? Why?
7. Mr. Nizak's cow is lying down in the רשות הרבים. Mr. Nizak's cow treads over the first cow and damages it. What is the law? Why?
8. Mr. Mazik's cow is walking in a רשות הרבים and eats a pile of premium quality vegetables that cost \$100 a pound. What is the law? Why?
9. Mr. Mazik's cow is walking in a רשות הרבים and eats a pile of wheat that costs \$5 a pound. What is the law? Why?
10. Mr. Mazik's cow, which is worth \$20, is walking in a רשות הרבים and eats a rubber tire worth \$50. What is the law? Why?
11. Mr. Mazik's cow is standing in Mr. Nizak's field. It stretches its neck and takes Mr. Nizak's premium quality vegetables that cost \$100 a pound, which are in the רשות הרבים. He eats them in Mr. Nizak's field. What is the law? Why?
12. Mr. Kelev walks into Mr. Nizak's field. He takes \$100 worth of premium quality vegetables and goes into Mr. Plony's field and eats it there. What is the law? Why?
13. Mr. Mazik's pig ate a \$100 steak in a רשות הניזק. What is the law? Why?
14. What is the law in the above case, if it occurred in a רשות הרבים? Why?
15. What is the law if a dog, worth \$40, eats small sheep worth \$100 in a רשות הניזק? Why?
16. A בהמה eats \$10 worth of bread that is in a \$6 basket. After eating all the bread up, he then breaks the basket. What is the law? Why?
17. What is the law if a בהמה, who is walking in a רשות הרבים eats \$60 worth of vegetables from in front of a store? Why?
18. Mr. Mazik's בהמה is walking in a רשות הרבים and eats \$5 worth of vegetables from off of the back of Mr. Nizak's בהמה. What is the law? Why?
19. Mr. Mazik's בהמה is walking in a רשות הרבים and slips on a rock. He falls into a רשות הניזק and squashes \$50 worth of tomatoes. It then proceeds to eat \$500 worth of vegetables over the next three hours. All during this time, Mr. Mazik was in the hospital waiting to fix his broken arm from his tripping on the same rock. What is the law? Why?
20. When is חצי נזק not a קנס?
21. BONUS (worth 5 points): Mr. Mazik's rooster, which is worth \$10, sticks its head into a glass bottle, which is in a רשות הניזק, that is filled with food worth \$50. While eating the food, he crows and his voice breaks the glass worth \$40. Mr. Mazik runs to the first circuit court under the jurisdiction of King Solomon and confesses what happened. What is the Law? Why?
